County Councillor Report

At the County Council Cabinet on 9th February, the council will vote on the proposal for a 1.99% increase and with a further 1.5% increase ring fenced for Adult Social Care. This represents a further £1 a week on the Average Band D Council Tax. The county council will maintain services to support residents during pandemic and only previously allocated savings/cuts of £10 million would be made.

The Clinical Commissioning Group for East Sussex continues to increase the vaccination roll out. A Rye surgery is offering vaccinations at the weekend with another surgery to come online the week after the meeting. Etchingham hub is working well.

Residents were asked to continue reporting potholes. The weather is wearing off the Stewards road markings so residents may have to report the pothole again.

Public Questions

A councillor informed the council that the dial-a -ride had ferried 200 people to Etchingham for their vaccination.

- 4.3 Applications considered by the parish council
- a) RR/2020/2222/P and 2223/L Park Farm, Wittersham Road: Proposed conversion of first floor and part ground floor of outbuilding to a residential annexe ancillary to the main building. It was resolved to support with the following comment In principle the parish council would support but as there is a degree of ambiguity in the purpose, we would require further information before giving any view on this application, particularly bearing in mind the property's listed status and historical significance- we would not wish this to create any precedent outside of the development area.
- b) RR/2020/2221/P Park Farm, Wittersham Road: Proposed erection of 2 bay garage, proposed erection of greenhouse. It was resolved to support.
- c) RR/2020/2219/P and 2220/L Park Farm, Wittersham Road: Proposed reduction of utility room and insertion of double doors in kitchen. Internal alterations to ground floor utility and kitchen area and layout of first floor master's bedroom and ensuite. It was resolved to support.
- d) RR/2020/2459/P May House, Wittersham Road: Adapt and extend existing two storey dwelling with construction of new single storey annex and pool house. It was resolved to support.
